1. Payment Terms

2. Sponsor Responsibilities for Promotional Materials and Event Equipment

The sponsor agrees to provide any necessary logos or branded items promptly to ensure their inclusion in event materials. The Club reserves the right to approve all Sponsor-provided items for appropriateness and alignment with Club standards. For tournaments and outdoor events, the Sponsor shall also provide a table, tent, and chairs as needed.

3. Club Obligations

The Club agrees to acknowledge the sponsors as outlined in The Solivita Smashers Pickleball Club Sponsorship Opportunities and acknowledge the Sponsor in accordance with the sponsorship level selected.

4. Termination

Either party may terminate this Agreement with written notice if the other party breaches any obligations and fails to remedy the breach within 14 days of receiving such notice. This Agreement shall be governed by and construed in accordance with the laws of the State of Florida, without regard to its conflict of laws principles.

The Solivita Smashers Pickleball Club Inc., reserves the right to use any photograph/video taken at any event sponsored by the Club or Castle Group and the respective community the event is happening in, without the expressed written permission of those included within the photograph/video. The Club may use the photograph/video or other media material produced, used or contracted by The Club including but not limited to brochures, invitations, books, newspapers, magazines, television, websites, etc. To ensure the privacy of individuals and children, images will not be identified using full names or personal identifying information without the written approval from the photographed subject, parent, or legal guardian.

9. Entire Agreement

This Agreement constitutes the entire understanding between the parties and supersedes all prior agreements, understandings, or discussions regarding the subject matter herein. Any amendments must be in writing and signed by both parties.
